6. Unless otherwise stated, terms used in the proxy form shall have the same meanings as defined in the circular of the Company dated 28 November 2025. Such circular is also available on the websites of the Stock Exchange (www.hkexnews.hk) and the Company (www.hipine.com). The proxy form must be signed by you or a person duly authorized by you in writing. Where the shareholder is a corporation, the proxy form must be either executed under its common seal or signed by its legal representative or director or duly authorized attorney.

In the case of joint shareholders, any one of the joint shareholders may vote (either in person or by proxy) at the EGM in respect of the shares concerned, as if he/she were the sole holder of the shares. However, if more than one of the joint shareholders attend the EGM in person or by proxy, the Company will accept the vote of the joint shareholder who ranks first in the register of members on the shares concerned (whether in person or by proxy), and the other joint shareholders will have no voting rights.

In order to be valid, this proxy form must be lodged at the Company's H share registrar, Tricor Investor Services Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong (in respect of H Shareholders) or the Company's Board office at 3701A, Shuibei International Jewellery Centre 2901, No. 99 Beili North Road, Cuijin Community, Cuizhu Street, Luohu District, Shenzhen, Guangdong Province, the PRC (in respect of Domestic Shareholders) at least 24 hours prior to the time appointed for holding the EGM or any adjournment thereof (as the case maybe) (i.e. before 2:00 p.m. on Thursday, 27 November 2025). If this proxy form is signed by another person authorized by the appointor by a power of attorney or other authorization document, such power of attorney or other authorization document must be notarized by a notary public. The notarized power of attorney or other authorization document, together with this proxy form, must be presented to the specified location by the time mentioned in the form. Completion and return of this proxy form does not affect your right to attend the EGM or any adjournment thereof in person and vote thereat. In such case, the proxy form will be deemed to have been cancelled. The appointee need not be a shareholder of the Company, but must attend the EGM in person to represent you.
